OneCare Vermont Accountable Care Organization, LLC Board of Managers Meeting March 16, 2021

Minutes

A meeting of the Board of Managers of OneCare Vermont Accountable Care Organization, LLC ("OneCare") was held remotely via video and phone conference on March 16, 2021.

I. <u>Call to Order and Board Announcements</u>

Board Chair John Brumsted, M.D., called the meeting to order at 4:31 p.m.

II. <u>Welcome Board Managers, Invited Guests, and Members of the Public</u>

Chair Brumsted welcomed new Board Manager representing Designated Agencies Bob Bick and thanked Dr. Jeff Haddock for service to the Risk Strategy committee. Chair Brumsted acknowledged and thanked Todd Keating for his service to the UVM Health Network and to the OneCare Board. Rick Vincent will replace Todd Keating as a UVMMC representative on this Board. Chair Brumsted welcomed presenter Stephen Graves, Diversity, Equity, and Inclusion (DEI) Consultant, presenter Kristi Cross, DNP, RN, Director of the Bennington Blueprint for Health, and members of the public in attendance.

III. Consent Agenda Items

The Board reviewed Consent Agenda Items including: (1) Draft of OneCare Public Session Minutes February 16, 2021; (2) Board Committee Reports March 2021; (3) Financial Statement Package January 2021; (4) CMO Corner March 2021; (5) Public Affairs Report March 2021; (6) Resolution Adopting Committee Reimbursement for Consumer Managers; (7) 2021 Quality Improvement Plan Endorsed by Population Health Strategy Committee; (8) Summary of Policy Changes March 2021; (9) 05-04 Subcontractor Management Policy; and (10) 06-19 Complaints, Grievances, and Appeals for Attributed Lives Policy. An opportunity for discussion was offered.

A Motion to Approve the Consent Agenda Items was made by S. LeBlanc, seconded by T. Dee and approved by a supermajority vote, with new manager B. Bick abstaining.

IV. Governance

Chair Brumsted introduced the resolution to approve a nominee to the Risk Strategy Committee and a nominee to the Finance Committee. Chair Brumsted described the nominees' respective qualifications. An opportunity for discussion was offered.

A Motion to Approve the Resolution Adopting Representatives to Committees was made by P. Parsons, seconded by C. Fort and approved by a unanimous vote.

V. <u>Diversity</u>, Equity, and Inclusion (DEI): OneCare Board and Committees Presentation

Vicki Loner, Chief Executive Officer, introduced Stephen Graves and thanked Mr. Graves and the OneCare team for conducting the DEI survey and compiling results. Ms. Loner shared that Mr. Graves' recommendations put Management on a positive path to expand diversity and the feeling of safety on our boards. Ms. Loner asked for the Board's input regarding next steps and timing and described that DEI work fits well with strategic planning, mission, vision, and values.

Stephen Graves, Senior DEI Consultant at All In Consulting, shared the results and findings of the DEI survey and recommendations to the Board of Managers. Survey responses illuminated gaps in representation of Black, Indigenous, and People of Color (BIPOC), the Transgender Community, and People with Disabilities, both physical and cognitive, on the Board of Managers and its Committees. Survey respondents recommended informing the path forward by seeking out people who will be represented, creating a culture of safety and inclusion, gaining trust in communities, and identifying health disparities. Mr. Graves presented next steps spanning principles, policies, processes, practices, and programs. Specific tactics include forming a DEI Committee of the Board of Managers and holding paid focus groups with members of the public who are BIPOC, Transgender, and People Living with Disabilities. Mr. Graves described that he and OneCare staff are taking step to hold focus groups, that participants will be members of the public, and that the purpose is to better understand their perspective regarding OneCare and what they would need to participate in governance. Mr. Graves explained that outreach to advocacy groups will clarify if other groups are also doing this work.

The Board discussed how to implement the recommendations and asked for time at each Board meeting to receive status updates and discuss DEI work. Discussion included the focus groups, other ongoing DEI initiatives, health disparities brought to light by the pandemic, and recruitment.

VI. Care Coordination: Bennington Health Service Area Presentation

Norman Ward, Chief Medical Officer, introduced Kristi Cross, DNP, RN, Director of Bennington Blueprint for Health, Project Director Bennington Opioid Response Team, and Co-Chair Bennington Community Collaborative, and described her clinical training, care coordination experience, and current innovative and successful work in the Bennington Health Service Area (HSA). Dr. Cross described care coordination framework principles used to achieve engagement in and integration of care coordination within existing workflows. Dr.

Cross shared an example of how care coordination could have prevented duplication of services when working with a patient to implement an automatic medication dispenser and noted that providing documentation templates and examples can support adopting care coordination tools. Dr. Cross shared that a centralized, secure, HIPAA-compliant care coordination platform gives organizations the ability to enhance care coordination. An opportunity for discussion was offered.

VII. Public Comment

There were no comments from the public.

VIII. <u>Move to Executive Session</u>

A Motion to move to Executive Session was made by T. Dee, seconded by Dr. J. Perras and was approved by a unanimous vote.

OneCare Board of Managers Committee Reports April 2021

Executive Committee (meets monthly)

At its April 1 meeting, the committee nominated a board manager to serve as a member of the executive committee, as a member of the audit committee, and as chair of the finance committee. The committee discussed the 2022 ACO participant network and strategic planning initiatives including review and development of OneCare's mission, vision, and values. The committee is scheduled to meet on May 5, 2021.

Finance Committee (meets monthly)

At its April 7 meeting, members approved the February financial statements and March meeting minutes. Two new policies were reviewed: (1) Financial Process for the Termination of Participant, Preferred Provider, and Collaborator Agreements; and (2) Assignment Policy for Attributed Lives. The Business Associate Agreement with PwC was shared in preparation for the 2020 audit of financial statements. The committee reviewed an updated Medicare sequestration report. The Finance Committee meets next on May 12, 2021.

Population Health Strategy Committee (meets monthly)

This committee meets next on April 12, 2021.

Patient & Family Advisory Committee (meets monthly)

At its March 23 meeting, the committee met with Stephen Graves, Senior Diversity, Equity, and Inclusion consultant at All In Consulting, to learn about upcoming steps OneCare leadership is taking to connect with communities who are BIPOC (Black, Indigenous, and People of Color), LGBTQ, and people living with disabilities for its board and committee work. The committee learned about recent work by the OneCare board of managers and continued reviewing the patient and family advisory committee charter. OneCare presented its initiative to outreach to members of the Medicaid expanded population to include additional Vermonters covered by Medicaid in the ACO, to improve access and connection for these Vermonters to a primary care provider, and to connect these Vermonters to a patient-centered medical home. The committee is next scheduled to meet April 27, 2021.

Clinical & Quality Advisory Committee (meets bi-monthly)

At its April 8 meeting, committee co-chair Dr. Mark Fung presented draft text designed to accompany laboratory reporting of glomerular filtration rate, a common measure of kidney function, to assist patients in understanding the implications of chronic kidney disease. Reduced kidney function can impact choice of certain medications, cautions when considering use of contrast for certain radiological studies, and the need for additional lab studies to gauge the degree of impairment (urine protein measurements.) There was a robust discussion regarding the recommendations. The committee reviewed a recommendation to examine the current practice of listing racial adjustments to kidney function tests from a from a health equity perspective. The committee reported on projects from a majority of Health Service Areas related to COVID vaccine initiatives, patient re-engagement efforts for preventive services, social determinants of health screening and coding, a pilot project of financial

incentives paid to staff for improved population health metrics, and the difficulty of transitions of care from incarceration to outpatient primary care. This committee meets next on June 10, 2021.

Pediatric Subcommittee (meets bi-monthly)

At its March 18 meeting, the committee reviewed analytics information regarding risk adjustment consideration for moving toward all-payer reporting. OneCare shared pediatric themes from the three Primary Care Workgroup sessions held in February and March of 2021. The committee also discussed the Section 1115 of the Social Security Act waiver. The committee meets next on May 20, 2021.

Laboratory Subcommittee (meets quarterly)

The committee is next scheduled to meet next June 1, 2021.

Prevention and Health Promotion Advisory Committee (meets quarterly)

The committee is next scheduled to meet on May 4, 2021.

Audit Committee (meets quarterly)

The committee is next scheduled to meet on May 12, 2021.

CMO Corner – April 2021

1. Health Service Area Consultations

The second round of meetings with each hospital leadership team began the week of April 5, 2021. A key emphasis of the meetings is to promote increased use of data available through OneCare to the participant network. OneCare is committed to training users to leverage the capabilities of data tools.

2. COPD/Asthma Learning Collaborative - April 8, 2021

Amy Yanicak, Assistant Professor at Albany College of Pharmacy, presented a clinical education session about appropriate therapy for patients with asthma and COPD. The presentation emphasized training patients to appropriately use metered dose inhalers, spacers, respimat devices, and dry powder inhalers. Three learning collaborative practice teams also presented mid-course updates regarding their quality improvement projects: St. Albans Primary Care, Supports and Services at Home (SASH), and UVM Medical Center Adult Primary Care.

3. Value-Based Incentive Fund Program 2021

OneCare Vermont teams are modeling methodologies to distribute payments to attributing primary care practices based on quality performance. For adult practices the measures are diabetes in control and hypertension in control; for pediatric practices, the measures are depression screening and developmental screening. In 2021, OneCare will provide quarterly snapshots of practice performance based on both manual abstraction of values in electronic medical records (EMRs) and electronically interfaced values directly from EMRs or from the Vermont Health Information Exchange. Payments for Performance Year 2021 will be made in July 2021 and in March 2022.



Media Coverage

UVM network developing new Medicare Advantage Insurance plan

The University of Vermont Health Network (UVMHN) announces their partnership with MVP Health Care to develop a Medicare Advantage insurance plan to better meet the needs of older adult patients across New York and Vermont. Network physicians will have a role in designing the new plan, which will begin in January 2022. Dr. John Brumsted, UVMHN president and CEO, notes that the partnership with MVP will amplify ongoing efforts to transform the way health care is delivered and paid for, including the work of OneCare Vermont.

Katja Evans fills community relations role at Gifford

Bennington hospital doubles down on nursing care; fewer patients admitted March 7, 2021, VTDigger

Southwestern Vermont Medical Center (SVMC) has been nationally recognized for their efforts to reduce hospitalizations by more than half through their transitional care model. SVMC's transitional care model provides continuity of services for at-risk patients moving from one physical setting to another. OneCare Vermont is mentioned in this piece as part of the reason they have been able to engage in transitioning away from fee-for-service to be able to be more innovative in the ways they deliver care, such as their successful transitional care program which reduced hospital revenue when it reduced in-patient hospitalizations.

OneCare's New Media Center

OneCare recently published a <u>media center</u> to support press inquiries regarding the ACO and its work. Government Relations

State Legislative Update

The Covid-19 Relief Bill and state budget continue to be the main focus of the current legislative session along with childcare and broadband. Senator Ginny Lyons introduced her comprehensive healthcare bill <u>S.132</u>. It is extensive and affects every aspect of the healthcare industry. OneCare is currently reviewing the bill and will continue to monitor and respond to the bill should it begin to move before the end of the current session.

On April 9, OneCare Vermont Chief Executive Officer Vicki Loner and Vice President of Finance Tom Borys provided the <u>Senate Health and Welfare Committee</u> an overview of the Comprehensive Payment Reform (CPR) Program. The committee was interested in how the program works and how it supports primary care. Ms. Loner also discussed the importance of Delivery System Reform (DSR) funding to support care coordination.

Green Mountain Care Board

The Green Mountain Care Board (GMCB) wrapped up its 2022 Hospital Budget Guidance discussions on March 23 and during its March 30 meeting, it presented an update on the 2019 All Payer Model Total Cost of Care (TCOC) and Quality Measures. The 2019 statewide quality and population health outcomes were presented and the state is currently on track to meet five of six population-level health outcomes targets, seven of eight available healthcare delivery system quality targets, and five of six available process milestones. It was presented that the model has brought more of Vermont health care system-wide under Vermont's regulatory control. The presentation can be found here. The scale target report will be coming in June 2021 and will include final numbers for 2020.

Outreach and Advocacy

OneCare Vermont: Reducing Health Care Spending and Improving Health Outcomes



OneCare Vermont and participating health care partners are working to transition the health care system in Vermont from what is called a "fee-for-service" model to a "value-based care" model. In this short video, learn what these two terms mean and why OneCare Vermont—our state's local accountable care organization—has undertaken the herculean task of transforming the way we pay for and deliver care. overview of OneCare's three core business areas that work in concert toward the mission to improve health outcomes and reduce health care spending.

Dinner Together for Social & Emotional Development

Results from the 2017 Youth Risk Behavior Survey (YRBS) of high school students showed that teens who regularly ate family meals participated in fewer risky behaviors and had significantly lower substance use. With this data as the driver, the RiseVT program manager in Addison County and her partners at Porter Medical Center and the Vermont Department of Health formed the Dinner Together initiative to encourage families to eat together—providing tips, recipes, and even meal-kits at local food shelves. A DULCE Success Story: Addressing Housing Conditions for a Family

In the spring issue of the Center for the Study of Social Policy's The DULCE Digest, a story was highlighted about a local family specialist at Lund, a Vermont non-profit organization that supports children and families, who helped a family get resources through DULCE (Developmental Understanding and Legal Collaboration for Everyone). DULCE is an intervention that takes place within a pediatric care office to address social determinants of health in infants, zero to 6 months, and provides support for their parents. OneCare Vermont supports the implementation of DULCE at pediatric practices around Vermont. Learn how a local mom was able to address immediate housing concerns, access childcare tuition assistance needs, and get started on the path to receiving training for future employment.

Diabetes Alert Day: How OneCare's Data Drove Innovation in Diabetes Management, Dramatically Reducing Blood Sugar Levels in Brattleboro

By partnering with OneCare, we were able to use data that helped us shape how we deliver care. Our diabetic community had A1C levels [a type of blood sugar measure] that were not well controlled. The data showed to us that we needed to do something different. Together, our team decided the best approach would be to embed a nurse practitioner who was focused on diabetes and lifestyle medicine, within BMH, to serve as a resource for our primary care practices. As a result, we have seen A1C levels go down dramatically. It's important that we continue with this work.



March 23, 2021 was American Diabetes Association Diabetes Alert Day. Diabetes is one of the primary drivers of health care spending in Vermont. Providers who are part of OneCare are able to leverage OneCare's data analytics to identify issues within a population and to rapidly develop targeted strategies to address identified issues.

Eilidh J. Pederson, MPH, COO of Brattleboro Memorial Hospital, described how OneCare's data was able to assist their organization in better shaping their care approach in managing diabetic Vermonters who had poorly controlled A1C levels (a blood sugar measure).

Asthma and COPD Learning Collaborative Videos

- **I. Purpose:** To outline the standards by which OneCare will meet key contractual obligations related to OneCare network development and composition.
- **II. Scope:** Applicable to the OneCare Workforce.
- **III. Definitions:** Capitalized terms have the same definition as defined in OneCare's *Policy and Procedure Glossary*.
- **IV. Policy:** OneCare will maintain a network of willing Participants, Preferred Providers, and Collaborators who desire to participate with the ACO for engagement in ACO Programs.
 - 1. OneCare will contract only with network Participants, Preferred Providers and Collaborators who are in good contractual standing with the respective payer(s) for the ACO Programs in which they participate.
 - 2. OneCare will not discriminate against any contracted network Participant, Preferred Provider or Collaborator who is acting within the scope of his/her license or certification under applicable state laws, solely on the basis of such license or certification.
 - 3. If OneCare declines participation to a health care provider or other organization who requests network participation, it shall inform that provider or organization of that decision in writing. The provider or organization may appeal that determination as permitted by 05-02 Participant & Preferred Provider Appeals Policy.
 - 4. OneCare will maintain a contracted network that includes sufficient numbers of facilities, physicians, ancillary providers, continuum of care providers, for the provision of high-quality covered services for Attributed Lives. That contracted network, together with non-contracted providers that Attributed Lives may seek care from, will meet the requirements for an adequate network found in ACO Program Agreements. OneCare does not prevent Attributed Lives from seeking care from providers who are not in the OneCare network.
 - 5. OneCare shall obligate its network Participants, Preferred Providers and Collaborators to adhere to the requirements and/or obligations contained in each ACO Program Agreement in which they participate in.
 - 6. OneCare will not restrict Attributed Lives from accessing care from any provider, in or out of OneCare's network.
- **V. Review Process:** This policy will be reviewed annually and in accordance with the terms of OneCare's ACO Program agreements with Payers.
